Local Meal Pricing Regulations

Breakfast Prices: PK – 12th \$1.25 Serving Time: 7:20 am to 7:50 am

Lunch Prices: PK – 5th \$2.00
6th - 12th \$2.25

Please remember we offer prepayment for your child(ren)'s meals in the cafeteria between **8:00 am - 10:30 am or 1:00 pm – 3:00 pm.**

Meals may be paid for daily, weekly or monthly; by check, cash or online at EZSchoolPay located on the district website: <http://www.itascaisd.org>
If sending cash we highly recommend that you place their money in a sealed envelope with their name, campus, and teacher's name if in elementary.

District regulations allows a 5 meal grace period before the student may receive an alternate meal, at which time the kitchen manager and campus administration will notify the parents/guardian regularly until payments or a payment plan has been made.
During the grace period where any negative balance exist, children will not be allowed to purchase items from the snack bar line.

If your child receives the alternate meal, the lunch will consists of a sandwich, fruit and milk.
